Voting members are eligible to hold office and participate in IFC activities subject to the by-laws of the Corporation.

**Associate Member** - Any entity, Company that does not meet the criteria for class A or Class A1 membership may become an Associate Member. Participation by Associate Member is encouraged. Associate members however, are not entitled to vote on council matters and not eligible for election as Officers or Directors of the Corporation.
